

## PRESENTATION OF THE FACULTY OF LAW, ECONOMICS AND TOURISM





The Faculty of Law, Economics and Tourism (FDET) of the University of Lleida (UdL) is located on the campus of Cappont. The UdL is one of the top three Spanish Public Universities in teaching quality and the second in employability.

The FDET offers studies in the fields of law, economics, business and tourism. It organizes several degrees, double degrees, masters and double masters, as well as a wide range of lifelong learning programs and other activities aimed at professionals and students, such as postgraduate programs and doctoral programs. It is one of the oldest centers at the University of Lleida and has one of the largest student bodies.

The degrees of the Faculty are aimed at educating professionals in the changing needs of society and business. For this reason, the curricula provides both theoretical and practical training, through a variety of internship opportunities. Undertaking an internship is compulsory, and can be pursued in companies and public or private institutions, thereby uniting professional and academic realities.

## DOUBLE DEGREE: DEGREE IN LAW AND DEGREE IN BUSINESS ADMINISTRATION AND MANAGEMENT

**Degree description:** The double degree itinerary in Law and Business Administration and Management (ADE) provides the training, knowledge and methodology of both fields. On the one hand, it forms professionals capable of carrying out management, consulting and assessment tasks in companies that can be developed at the global level of the organization or in any of the functional areas: production, human resources, finance, marketing, investment, administration or accounting. On the other hand, it provides a basic legal training that encompasses both theoretical knowledge about the legal system and the methodological tools necessary to interpret and apply its rules. Successful completion of this itinerary leads to the titles of Graduate in Law and Graduate in Business Administration and Management.

Consequently, the student acquires a double preparation from both the business and legal points of view, which increases employability. Thus, career opportunities include: The free exercise of the professions of lawyer and solicitor, once the corresponding master's degree has been passed. Legal advisor and consultant in public institutions and private companies. Participant in competitions to access the following professions: notary, registrar, civil servants of the administration of Justice, civil servants of the public administrations and international organisms, among others.

The exercise of the profession of economist. In particular, students are trained to become: investment and finance consultants, market analysts, fiscal advisors, auditor, sales directors and marketing experts, experts in accounting, managers and directors of companies, managing directors and directors of public organizations, and non-profit institutions.

## DOUBLE DEGREE: DEGREE IN BUSINESS ADMINISTRATION AND MANAGEMENT AND DEGREE IN TOURISM

**Degree description:** The double degree in Business Administration and Management and Tourism provides students the knowledge and skills of both degrees. Students acquire a foundational understanding of the tourism sector and they are trained to manage and run tourism companies and organizations. Each of the degrees complement and are integral to each other, creating highly trained business professionals with a specialized knowledge of the tourism field. Successful completion of this itinerary leads to both a Degree in Business Administration and Management and a Degree in Tourism.
